

In this regard, I have been directed to inform you that the Hon'ble Court has been pleased to grant permission to 47 Students and 05 Teachers on 24.04.2024 (Wednesday) at 10 a.m. and 46 Students and 05 Teachers on 25.04.2024 (Thursday) at 10 a.m. of Tender Hearts School, Lucknow to visit and to see the proceedings of the Hon'ble High Court at Lucknow with the following conditions:-

- (a) Students will be accompanied by 05 teachers bearing their Identity Card of Tender Hearts School, Lucknow and they will ensure that no disturbance is caused by the students in the High Court Premises.
- (b) Students shall be divided in five groups comprising of not more than 10 students in each group.
- (c) Entry will take place from Gate No.- 4. All the entrants will bear his / her Identity Card and submit photocopy of their Identity Card at the time of entry into the Campus of this Hon'ble Court. They will take their seats before the Hon'ble Court resumes proceedings.
- (d) All the entrants will keep their Cell Phones in switched off mode and will not raise any question or query in the Court Rooms so that no disturbance is caused during Court proceedings. Each student will wear proper uniform and will maintain proper decorum and discipline.
- (e) All the entrants be directed to follow the norms/guidelines issued by the Central / State Government with regard to COVID-19 during the visit to this Hon'ble Court.
